Your request must be received by the Corporate Secretary's office on or before April 25, 2016. If you hold your shares in street name through a bank, broker or other holder of record, you will be admitted only if you have proof of ownership as of the record date, February 29, 2016, such as a bank or brokerage account statement. All meeting attendees must present valid government-issued photo identification, such as a driver's license or passport. For safety and security reasons, cell phones, laptops, tablets, recording equipment, other electronic devices, large bags, briefcases and packages will not be permitted in the meeting.
