Explanation of Responses:

1. The filing being amended reflected in Table II the acquisition of 4,616 phantom stock units issued in connection with a deferral of a performance stock award under the Occidental Petroleum Corporation 1995 Incentive Stock Plan. Since the phantom stock units may be settled only in common stock on a one-for-one basis, the filing has been amended to report the acquisition solely in Table I.
2. The filing being amended reflected the disposition of 1,591 shares of restricted stock and the acquisition of an equivalent number of phantom stock units in connection with a deferral election under the Occidental Petroleum Corporation 1995 Incentive Stock Plan. Since the phantom stock units may be settled only in common stock on a one-for-one basis, the filing has been amended to report the shares solely in Table I.
